At a meeting of the board of directors (the "Board") of Galveston County Municipal Utility District No.6 (the "District") held on August 5, 2024, at which a quorum of said Board was present, as follows:

It was duly moved by Director Mark Domma,

discussion and the question being put to the Board of Directors, said motion was  
carried by the following vote:

The order thus adopted is as follows:

Whereas, it is required by statute that an election of directors of the District be held on the First Tuesday in November of 2024.

*WHEREAS*, Board of Directors of the District desires to enter into a contract with the County of Galveston, Texas to jointly conduct its director’s election in order to comply with State and Federal laws.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT NO. 6 THAT:**

An election shall be held on November 5, 2024, from 7:00 a.m. to 7:00 p.m., at the Galveston County Election Precinct Polling location(s) to be designated by Galveston County and which may be located online at [www.galvestonvotes.org](http://www.galvestonvotes.org) for the purpose of electing two (2) directors for said District, each to serve for four years. The entire District is declared one precinct for the purposes of said election. Only duly qualified resident voters of the District shall be entitled to vote at said election.

Voting in said election on Election Day shall be pursuant to a joint election contract with Galveston County and by the use of a Direct Recording Electronic voting system. The ballot language shall be in English and Spanish languages and shall conform to the requirements of the Texas Election Code.

Election judges and clerks, both for early voting and for Election Day, shall be selected by Galveston County and shall be compensated by Galveston County.

Early voting in the election by personal appearance shall begin on October 21, 2024 and shall continue through November 1, 2024. The polling places at which such early voting shall be conducted are determined by Galveston County and which may be located online at [www.galvestonvotes.org](http://www.galvestonvotes.org) and attached hereto with the respective hours of operation and made a part hereof for all purposes. The main

early voting polling place is located at Galveston County Justice Center, 600 59th Street, 1st Floor Break Room, Galveston, Texas 77551 with additional polling places designated by Galveston County. The early voting clerk shall keep the early voting place(s) open according to a schedule set by Galveston County, which may be located online at [www.galvestonvotes.org](http://www.galvestonvotes.org).

The early voting clerk's mailing address to which ballot applications and ballots to be voted by mail may be sent is Attn: Ballots by Mail, c/o Dwight Sullivan, Galveston County Clerk's Office, P. O. Box 17253, Galveston, Texas 77552-7253.

The election shall be held and conducted and returns made to this Board of Directors in accordance with applicable provisions of the Texas Election Code and the Texas Water Code. Galveston County shall appoint an Early Voting Ballot Board to process early voting results from the joint election. The Presiding Judge, with the assistance of the Galveston County elections department, shall appoint two or more additional members to constitute the Early Voting Ballot Board.

The President and Secretary of the Board are hereby authorized and directed to secure and provide such election supplies as may be necessary for the conduct of such election, including but not limited to the execution of a contract or lease agreement with Galveston County concerning election equipment and associated training and technical support; to cause notice of this election to be posted as required by law in English and Spanish not later than the twenty-first (21st) day

before the date of the election at a public place in the District's election precinct in the jurisdiction of the District; to cause a copy of the notice of the election to be posted, on the bulletin board used for posting notice of the meetings, not later than the twenty-first day before election day; and to take such other steps as may be necessary or appropriate in the calling and conduct of such election. The Secretary or the Secretary's designee is hereby authorized on receipt of certification required by Sec. 2.052(b) Election Code to post notice at each polling place that the election is not to be held.

Spanish language assistance to voters will be available by contacting the Early Voting Clerk or the Presiding Judge.

The Board of Directors has appointed Dick H. Gregg, III of Gregg & Gregg, PC, as the District's agent for the election. The offices of the District's agent are located at 16055 Space Center Boulevard, Suite 150, Houston, Texas 77062 and are open from 8:00 a.m. to 5:00 p.m. each Monday through Thursday and 8:00 a.m. to 12:00 p.m. on each Friday.

Candidates for the office of Director may file with the Secretary of the Board of Directors applications to have their names printed on the ballots to be used at said election. Such applications shall be signed by such candidates and shall be filed at least seventy-eight (78) days prior to the date of such elections, said deadline being

August 19, 2024. Write-in candidates for the office of Director must file with the District by August 24, 2024.

The President or Vice President and Secretary or any Assistant Secretary of the Board of Directors or the attorney for the District are authorized and directed to execute and post as required by law a notice of said election, and to do all other things proper and necessary for the consummation of said election.
